Dear Neighbor,

As always, I have continued to be relentless in my demands for accountability for the corruption behind HB 6. To see the wide-reaching effects of this bill in practice, my colleague Rep. Jeff Crossman (D-Parma) and I took a <u>road trip</u> to Madison, Indiana, last month. Madison is home to 12,000 Hoosiers and the coal-fired plant that Ohio utility ratepayers are currently subsidizing. That bailout is still costing Ohio taxpayers \$232,000 a day, or nearly \$10,000 **every single hour.** We met with local elected officials in Madison who had no idea that one of their biggest local employers is being propped up Ohio dollars. Just consider where that money could be better spent if we

invested in clean energy initiatives right here in Ohio.

I hope you'll join me at my upcoming Legislative Town Hall on **November 9th at 6:30pm at the Hudson Library** to discuss this more. I will be joined by SeMia Bray of the Black Environmental Leaders Association to discuss my latest bill, <u>HB 429</u>: The Energy Jobs & Justice Act, as well as current Ohio legislation and redistricting. Spotlight: Ohio Redistricting

In 2018, Ohioans voted overwhelmingly in favor fair districts for our state, and at the Statehouse, we are currently working to draw new congressional districts. Because the Redistricting Commission failed to pass a bipartisan, 10-year map by Oct. 31, the responsibility for redistricting has returned to the General Assembly. The legislature can now either pass a bipartisan 10-year map or a short-term partisan map by **Nov. 30.** Republicans in both chambers <u>introduced maps</u> this week that clearly do not live up to the spirit of what voters asked for.



As for Statehouse seats, the Redistricting Commission voted on September 15 along partisan lines to adopt a 4-year map. The new GOP Commission maps are gerrymandered and NOT what Ohioans voted for. These maps would likely give Republicans a 62-37 advantage in the House and 23-10 in the Ohio Senate—**veto-proof majorities** in



both chambers. These maps have been taken to the Ohio Supreme Court, so we do not consider them final.

Ohioans and Democrats still want to see bipartisan, 10-year maps that keep our communities together and reflect the preferences of Ohio's voters. Fair districts means districts that do not have undue, unfair favoring of one party, and keep large cities together so Ohioans who live and work together can get the representation they deserve.

With fair districts, we can fund our schools fairly, create good paying jobs, and stop pushing through extremist legislation that does nothing but divide us.

Legislative Update

HB 3, better known as **Aisha's Law**, was initially unveiled as bipartisan <u>priority legislation</u> in the 133rd General Assembly, and is sponsored by Rep. Janine Boyd and Rep. Stephanie Carruthers. Aisha's Law is named after Aisha Fraser, who was <u>killed</u> on Nov. 17, 2018 by her ex-husband, Lance Mason, following years of domestic abuse.

Aisha's Law would improve how law enforcement agencies respond to domestic violence cases and

provides added protections for those in high-risk situations. In the last month, Aisha's law passed out of the Ohio House, and now moves on to the Senate for consideration.
