

Federal Government to End SNAP Emergency Allotments after February

Due to changes in federal law, February will be the last month of emergency Supplemental Nutrition Assistance program (SNAP) allotments. Ohio Department of Jobs and Family Services Director Matt Damschroder stated that they, "will be communicating to recipients, county agencies, and our partners such as foodbanks, that normal SNAP payment will resume in March." The Consolidated Appropriations Act of 2023 ended the emergency program, and as this is a federal change, there are no fair hearing rights or fair hearing benefits on the ending of the SNAP emergency funds.
