The 135th General Assembly's Capital Budget process is finally underway. The Capital Budget occurs every two years, and primarily funds the capital assets and infrastructure needs of state agencies and public institutions as well as supporting several grant and loan programs for local infrastructure projects throughout the State.

Eligible uses of funds will support the acquisition, construction, reconstruction, rehabilitation, remodeling, renovation, enlargement, improvement, equipping, and furnishing of capital facilities for projects demonstrating a state benefit for higher education, mental health, parks and recreation, conservation, and cultural and sports facilities.
