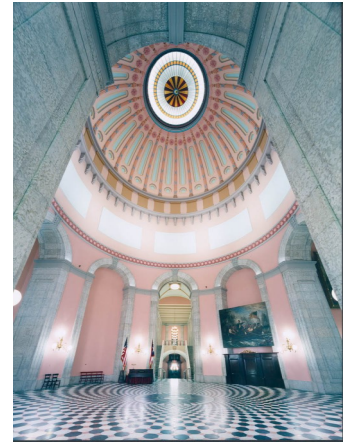

With the start of the new General Assembly in January of 2023, a contentious vote for House Speaker, and the work on the State Operating Budget, it has been an incredibly busy year. As we navigate through the dynamic landscape of legislative changes, policy developments, and regulatory updates, I am excited to provide you with a comprehensive overview of the progression of the bills I have introduced over the course of this year.

# Ohio Commission on Minority Health Grant

The Ohio Commission on Minority Health has a variety of biannual grant opportunities. This year, an Infant Mortality Hub Grant was awarded to the Lorain County Pathways HUB program run by the Lorain County Community Action Agency. This funding allows for the the replication and expansion of the Certified Pathways Community HUB model to try to address infant mortality rates in Ohio.

The Lorain County Pathways HUB is a free program seeking to reduce infant mortality and improve the health of at-risk moms and infants in Lorain County. The program is designed to link individuals with a local, trusted and caring Community Health Worker, who focuses on the health of you and your children. The key goals are as follows:

- Reduce and eliminate Ohio's infant mortality rates and barriers that prevent mothers from receiving excellent pre-natal and post-partum care.
- Assist pregnant women throughout their pregnancy and up to their child's first birthday.
